

## ALTSHULER SHAHAM

## Dear Client,

Under Section 16 of the Provisions of the Regulation of Investment Advice, Investment Marketing and Investments Portfolio Management Law, 5755-1995 (the "Law"), Altshuler Shaham Investment Portfolio Management Ltd. (the "Company"), as a portfolio manager engaged in management of investment portfolios or investment marketing, is entitled within the framework of its investment marketing or portfolio management activities, as applicable, to prefer a financial asset with which it is affiliated, over other financial assets similarly suitable to the client and with which it has no affiliation, as long as all disclosure requirements with regard to the client, have been fulfilled.

The Company hereby announces that it is an affiliated corporation of an institutional entity, within the meaning thereof in the law, Altshuler Shaham Mutual Funds Management Ltd. (the "**The Fund Manager**") and Altshuler Shaham Provident Funds and Pension Ltd., a public company whose shares are traded on TASE, and is an affiliated corporation of Altshuler Shaham Financial Services Ltd., Altshuler Shaham Properties Ltd., Altshuler Shaham Trusts Ltd., Altshuler Shaham Benefits Ltd., Altshuler Shaham Alternative Ltd., and of corporations that manage hedge funds that are owned by Altshuler Shaham, and that the Fund Manager acts as a representative, as this term is defined in the Joint Investment Trust Regulations (Foreign Fund Unit Offerings), 5776-2016 and as specified therein, and a marketer of funds managed by BlackRock (Luxembourg) Ltd. and BlackRock Asset Management Ireland Ltd. and of these fund managers (jointly: the "**Foreign Fund Manager**"), (collectively: the "**Affiliates**"). Therefore, the Company has a link to the mutual funds managed by Altshuler Shaham Mutual Funds Management Ltd. and to the provident funds and pension funds that are managed by Altshuler Shaham Mutual Funds and Pension Ltd., as well as to the financial assets managed by the Foreign Fund Manager.
